You are required to attend.** If a company is not represented at the on-site pre-quote conference, he will not be permitted to submit a quote.

**NOTE:** Each vendor submitting a response to this request will be responsible for providing any or all of the services listed below, as described, when in receipt of a Chatham County Purchase Order for such items or services. "Chatham County is an Equal Opportunity Employer," M/F/H, all bidders are to be Equal Opportunity Employers M/F/H.

Local Preference: On 27 March, 1998, the Chatham County Board of Commissioners adopted a "**Local Vendor**" Preference Ordinance that gives the lowest Chatham County vendor submitting a responsible bid/quote the opportunity to match the lowest price offered by an out-of-County vendor. If the County vendor confirms in writing to match within 24 hours, the award will be made to the Chatham County vendor. The lowest Chatham County responsive bidder will be afforded the "right to first refusal". "Local Vendor" is defined as a business or supplier which operates and maintains a regular place of business within the geographical boundaries of Chatham County, or one of the local Municipalities of the County *AND* all real and personal property taxes are paid prior to award of a contract or purchase. **NOTE: Local Preference does not apply to Public Works construction contracts.**

Chatham County has established goals to increase participation of minority and female owned businesses. In order to accurately document participation, businesses submitting bids or proposals are strongly encouraged to report ownership status. ### **GENERAL TERMS, CONDITIONS, AND EXCEPTIONS**

- 1.11 Guarantee:** Unless otherwise specified by the County, the bidder shall unconditionally guarantee the materials and workmanship on all material and/or services. If, within the guarantee period any defects occur which are due to faulty material and or services, the contractor at his expense, shall repair or adjust the condition, or replace the material and/or services to the complete satisfaction of the County. These repairs, replacement or adjustments shall be made only at such time as will be designed by the County as being least detrimental to the operation of County business.
- 1.12 Qualification of Business (Responsible Bidder or Proposer):** A responsible bidder or proposer is defined as one who meets, or by the date of the bid acceptance can meet, all requirements for licensing, insurance, and service contained within this Invitation for Bids or Proposals. Chatham County has the right to require any or all bidders to submit documentation of the ability to perform, provide, or carry out the service or provide the product requested.
- 1.13 County Tax Certificate Requirement:** Contractor must supply a copy of their Tax Certificate as proof of payment of the occupational tax where their office is located. Please contact the Chatham County Department of Building and Regulatory Services at (912) 201-4300 for additional information.
- 1.14 Delinquent Real and Personal Property Taxes:** No contract shall be awarded unless all real and personal property taxes have been paid by the successful contractor and/or subcontractors as adopted by the Board of Commissioners on 8 April 1994.
- 1.15 Insurance Provisions:** The selected CONTRACTOR shall be required to procure and maintain for the duration of the contract insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of

the work hereunder by the Contractor, his agents, representatives, employees or subcontractors. The cost of such insurance shall be included in the Bid. **Contract work will not proceed unless Chatham County has in their possession, a current Certificate of Insurance.**

1.15.1 General Information that shall appear on a Certificate of Insurance:

- I. Name of the Producer (Contractor's insurance Broker/Agent).
- II. Companies affording coverage (there may be several).
- III. Name and Address of the Insured (this should be the Company or Parent of the firm Chatham County is contracting with).
- IV. A Summary of all current insurance for the insured (includes effective dates of coverage).
- V. A brief description of the operations to be performed, the specific job to be performed, or contract number.
- VI. Certificate Holder (This is to always include Chatham County).

**Chatham County as an Additional Insured:** Chatham County invokes the defense of sovereign immunity. In order not to jeopardize the use of this defense the County **is not** to be included as an Additional Insured on insurance contracts.

1.15.2 Minimum Limits of Insurance to be maintained for the duration of the contract:

- A. **Commercial General Liability:** Provides protection against bodily injury and property damage claims arising from operations of a Contractor or Tenant. This policy coverage includes: premises and operations, use of independent contractors, products/completed operations, personal injury, contractual, broad form property damage, and underground, explosion and collapse hazards. Minimum limits: \$1,000,000 bodily injury and property damage per occurrence and annual aggregate.
- B. **Worker's Compensation and Employer's Liability:** Provides statutory protection against bodily injury, sickness or disease sustained by employees of the Contractor while performing within the scope of their duties. Employer's Liability coverage is usually included in Worker's Compensation policies, and insures common law claims of injured employees made in lieu of or in addition to a Worker's Compensation claim. Minimum limits: \$500,000 for each accident., disease policy limit, disease each employee and Statutory Worker's Compensation limit.
- C. **Business Automobile Liability:** Coverage insures against liability claims arising out of the Contractor's use of automobiles. Minimum limit: \$1,000,000 combined single limit per accident for bodily injury and property damage. Coverage should be written on an "Any Auto" basis.

### 1.15.3 Special Requirements:

- A. **Claims-Made Coverage:** The limits of liability shall remain the same as the occurrence basis, however, the Retroactive date shall be prior to the coincident with the date of any contract, and the Certificate of Insurance shall state the coverage is claims-made. The Retroactive date shall also be specifically stated on the Certificate of Insurance.
- B. **Extended Reporting Periods:** The Contractor shall provide the County with a notice of the election to initiate any Supplemental Extended Reporting Period and the reason(s) for invoking this option.
- C. **Reporting Provisions:** Any failure to comply with reporting provisions of the policies shall not affect coverage provided in relation to this request.
- D. **Cancellation:** Each insurance policy that applies to this request shall be endorsed to state that it shall not be suspended, voided, or canceled, except after thirty (30) days prior to written notice by certified mail, return receipt requested, has been given to the County.
- E. **Proof of Insurance:** Chatham County shall be furnished with certificates of insurance and with original endorsements affecting coverage required by this request. The certificates and endorsements are to be signed by a person authorized by the insurer to bind coverage on its behalf. All certificates of insurance are to be submitted prior to, and approved by, the County before services are rendered. The Contractor must ensure Certificate of Insurance are updated for the entire term of the County.
- F. **Insurer Acceptability:** Insurance is to be placed with an insurer having an A.M. Best's rating of A and a five (5) year average financial rating of not less than V. If an insurer does not qualify for averaging on a five year basis, the current total Best's rating will be used to evaluate insurer acceptability.
- G. **Lapse in Coverage:** A lapse in coverage shall constitute grounds for contract termination by the Chatham County Board of Commissioners.
- H. **Deductibles and Self-Insured Retention:** Any deductibles or self-insured retention must be declared to, and approved by, the County. At the option of the County, either: the insurer shall reduce or eliminate such deductibles or self-insured retention as related to the County, its officials, officers, employees, and volunteers; or the Contractor shall procure a bond guaranteeing payment of related suits, losses, claims, and related investigation, claim administration and defense expenses.

- 1.16 **References:** Provide with the quote, references from owners of at least three (3) projects of various sizes. Include government owners if possible. If the contractor has performed any work for the Chatham County Board of Commissioners within the last five (5) years, at least one (1) of the three (3) owner references must be from the appropriate party within the Chatham County Government. **Provide references on the sheet provided in the packet.**
- 1.17 **DEBARRED FIRMS AND PENDING LITIGATION:** Any potential proposer/firm listed on the Federal or State of Georgia Excluded Parties Listing (Barred for doing business) **will not** be considered for contract award. Proposers **shall** disclose any record of pending lawsuits, criminal violations and/or convictions, etc., and shall not have conflicts of interest. Any proposer/firm previously defaulting or terminating a contract with the County will not be considered. A Statement of Disclosure **must** be provided with response.
- 1.18 **State Licensing Board for General Contractors:** pursuant to Georgia law, the following types of contractors must obtain a license from the State Licensing Board of Residential and General Contractors by 1 July 2008:
- \*Residential-Basic Contractor** (Contractor work relative to detached on-family and two-family townhouses not over three stories in height).
  - \*Residential-Light Commercial Contractor** (Contractor work or activity related to multifamily and multiuse light commercial buildings and structures).
  - \*General Contractor** (Contractor work or activity that is unlimited in scope regarding any residential or commercial projects).
- A copy of your licence must be a part of your bid documents at the time of the bid opening. \*\*THE REQUIREMENTS FOR THIS PROJECT WILL BE A COPY OF YOUR BUSINESS LICENSE.\*\***

## SCOPE OF SERVICES

### **CONSTRUCT SIDEWALKS AT LAMARVILLE PARK AND WESTLAKE PLAYGROUND**

#### **2.1 GENERAL INFORMATION:**

The purpose of this request is to obtain the quotes for the installation of concrete sidewalks at Lamarville and Westlake Parks as per the following specifications. Maps of each park are attached.

## 2.2 WORK REQUIREMENTS:

1. Provide and install 150 linear feet of new concrete sidewalk from existing walks at entrance to the park going around to the left side of playground and to the right of basketball court to the new concrete slab at the Lamarville Park. Also add a 10' x 6' x 4" walk to the playground. Total walk 220' x 6' x 4" with 3,000 psi concrete with fiber.
2. Provide and install 220 linear feet of new concrete sidewalk, 135' x 8' x 6", from curb to new building slab at Westlake Playground. The sidewalk goes between the playground and the basketball court. To include a 15' x 8' x 6" walk to the playground. Total walk 15' x 8' x 6" with 3,000 psi concrete with fiber.
3. Contractor shall provide fill dirt as required. A separate quote will be provided per truck load to include labor
4. Contractor shall supply all necessary materials, equipment, tools, supervision, consumables and traffic control devices to perform the activities listed above.
5. Forms shall be wood or metal, straight, free from warp, of sufficient strength to resist spring during concreting operations, and kept in place a minimum of (24) hours.
6. Finishing shall include floating concrete until one-quarter (1/4) inch of cement gel is brought to the surface. Steel trowel until dense surface is obtained. Finish with broom at right angles to alignment of walk, then round all ends with one quarter (1/4) inch radius after brooming. The brooming shall not create any sag area near the edge of the new sidewalk.
7. Expansion joints shall be full depth at 40 feet intervals and should match joints in existing curb and gutter. The expansion joint shall be 1/2 inch pre-molded and continuous. Expansion joint (s) shall be also be formed where existing concrete adjoins the new sidewalk.
8. Contraction joints shall be one quarter (1/4) of slab thickness at maximum 4' x 4' approximate grid pattern. The preferred method is for joint (s) to be saw cut within 24 hours of concrete placement.
9. Sidewalks will be installed in accordance with ADA standards regarding ground level and the one foot per inches rule regarding elevated landing or slabs.
10. Contractors are responsible for all utility locates, verification and damage to any utilities. Also extreme caution to protect any existing trees and root systems.

11. Should tree roots be present during preparation, under no circumstances are they to be cut or trimmed. Guidance will be provided by the Project Manager. No additional payment will be permitted for mobilization, demobilization, lost time, and/or multiple visits to the site.
12. Driving of concrete trucks within the park is allowed based on soiled conditions. Any ruts or deep holes in grass or sod will be repaired by the vendor.
13. Work is to be performed 8:00AM–5:MP Monday–Friday. Weekend work maybe requested by contacting the project manager.
14. All traffic control and traffic control devices shall conform to Manual of Uniform Traffic Control Devices, Millennium Edition. The contractor shall provide all necessary equipment, including but not limited to, cones, barrels, signs and flashing arrows. Barricades shall not be removed until project is completed.
15. Contractor shall ensure that the site is cleaned up, all extraneous materials removed, and that once the formwork is removed the adjacent disturbed areas are backfilled with soil, the backfill placed such that it's level with the finished sidewalk and blended to the existing topography.

## Attachment D

### IMMIGRATION AND SECURITY FORM

SB529 (The Ga Security and Immigration and Compliance Act) requires contractors to file an affidavit that the contractor and its subcontractors have registered and participate in a federal work authorization program intended to insure that only lawful citizens or lawful immigrants are employed by the contractor or subcontractor. This requirement of SB529 is a phased-in affidavit filing requirement based on the size of the contractor.
