**Please be advised of the following clarifications:**

1. The scope of work has changed. During the walk of the proposed trail , the western segment traverses into an area of bottomland, which would be difficult for any mechanical work due to its boggy conditions and probably would be accessible only during certain times of the year to users.

**Please see attached new picture of the area for the construction of the trail.**

2. Parking Area Page 18; #2.
  - A. **There are a few small trees to be removed.**
  - B **Chatham County will provide mulch but the contractor will be responsible for loading, hauling and placing the material.**
  - C. **The depth of the mulch in the parking area should be six (6) inches. No mucking, fabric or stone base required.**

3. Entry Road Page 18; # 3.

**The depth of crush-and-run along the entry road from Fort Argyle Road should be at least six feet wide and six inches deep.**

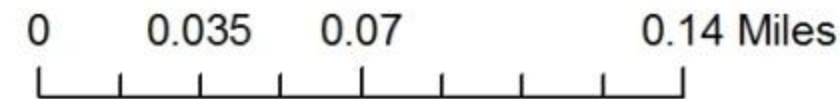
