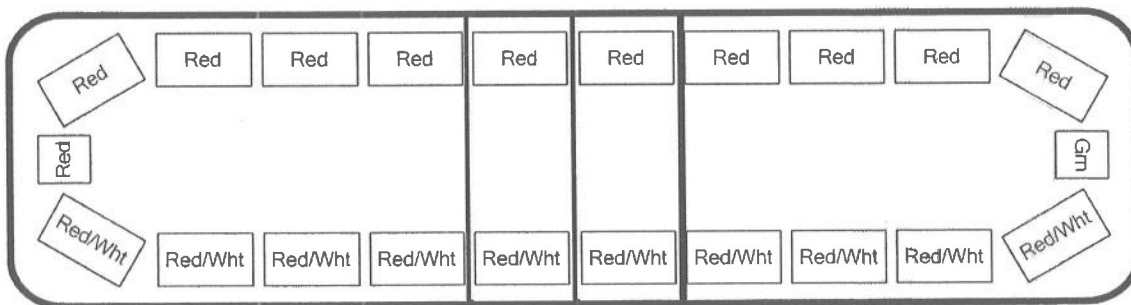

### Lenses/Diffusers/Base Color

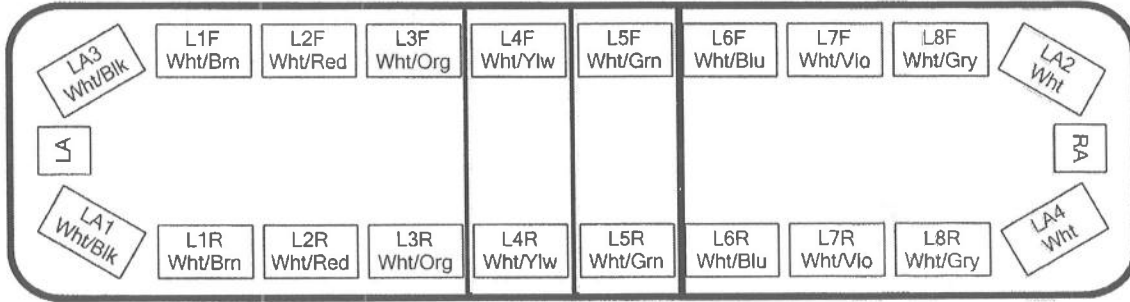


### Control Cable Wiring
