- Question:** Ref. Section 2.16.2 Minimum Limits of Insurance - According to the FMCSA-DOT, when transporting 15 passengers or less, the required amount of insurance is \$1.5 million. When transporting more than 15 passengers the required amount of insurance is \$5 million. Would the County consider raising the insurance limits to \$5 million?

Response: The contractor must meet or exceed Federal Motor Carrier Safety Administration (FMCSA) insurance requirements. These requirements supersede County requirements as stated in section 2.16.2.a.
- Question:** Ref. Section - 4.3.3- Does the corporation or LLC have to be operating under the same name for 3 consecutive years?


Response: Yes.
