1. **Question:** Does the County have any historical records of product that is collected?

Response: The locations listed in the RFP do not have scales and this service has not been contracted in the past.

2. **Question:** Would the County be open to alternative proposals? (i.e. contractor doing work onsite)

Response: No, the footprints at many of the locations on this project do not have space for a contractor to conduct composting operations.

3. **Question:** Can the County provide addresses for the four locations referenced in Section 5.1?

Response: The locations and addresses are as follows: **Wilmington Island Drop-Off Center**, 7022 Concord Road, Savannah, GA, **Chevis Road Drop-Off Center**, 610 Chevis Road, Savannah, GA, **County Lot #1**, 7235 Sallie Mood Drive, Savannah, GA. **County Lot #2**, 561 Bush Road, Savannah, GA

4. **Question:** Are the sites available for contractor's to view?

5. **Question:** Ref. Section 4.5.2 – What is acceptable certification?

Response: US Composting Council Certification is acceptable.

6. **ADDITION:** Ref. Section 5.2 – Add to Scope of Services. Contractor is responsible for disposal of contaminants. Successful contractor shall follow Georgia EPD Chapter 391.3.4 Rules for Solid Waste Management for Compost. Successful contractor shall provide an up to date permit for composting operation.

7. **ADDITION:** Ref. Section 5.3.6 – Add D. Contractor shall provide Seal of Testing Assurance (STA) results to the County's point of contact each month.

8. **CHANGE:** Revised Bid Sheet - Replace bid sheet with REVISED bid sheet.
Bidders shall use revised bid sheet when submitting bid.
