PLEASE SEE THE FOLLOWING ADDITIONS, CLARIFICATIONS AND/OR CHANGES:

1. **Question:** I have not been able to source the rifle shield: Rifle Shield – Paraclete ASPIS-X Gen II Level III rifle shield with viewport and light, size 21x36 (SH3PTFXMV1H5L2) noted in the specification. Will a shield with dimensions of 20X20 be acceptable?

Answer: We will accept a size of 20x30, not 20x20.

2. **Question:** How soon after the bid is awarded is the equipment required to be in Savannah?

Answer: Please see revised bid sheet attached that will have a line to write in your estimated delivery time.

3. **Question:** Regarding Line 4.2.10, please advise if the bid requires a saw blade or if this is just the saw only. If a blade is required, please advise the size:
Option One: 12” x 24T Blade
Option Two: 14” x 30T Blade

Answer: A blade is required. Option one: 12x24T Blade is acceptable.

4. **Question:** Regarding items 4.2.7 and 4.2.8, both of these items have been discontinued and are not available. Would you accept alternatives?

Answer: We will accept equivalent alternatives.


