1. Four Quarterly inspections to include:
 - a. Check all controls
 - b. Inspect for function and operation
 - c. Test and record all motors amperage load
 - d. Lubricate all bearings and wear points
 - e. Open access panels to clean interior and exterior sections
 - f. Inspect and record all drive bearing and motor temperatures
 - g. Inspect all pressure and safety switches
 - h. Inspect all drive couplers for wear and damage
 - i. Clean and Inspect grinders and blades for wear and or damage
 - j. Remove, Clean and Inspect lift pumps for wear and or damage
 - k. Inspect lift station well for wear and or damage Confined Space Permit's must be included in price

All inspections must conform to manufacturer specifications.

An inspection checklist with all information and results for each item on inspection must be provided for each inspection for review and records. All inspection paperwork must be received at completion of inspection signed by inspector.

All inspections must be scheduled with notification by phone or email to confirm time and date at least 72hrs. before inspection is due.

Failure to notify Engineering will result in rescheduling the inspection with no charge to Chatham County Sheriff's Office.

All inspections must be escorted by a Chatham County Detention Center Facility Engineer.

Inspection cancellations by either party must be made by phone or email no less then 24hrs in advance. All cancelations must be rescheduled at time of cancellation.

This annual contract will be for one (1) year with the option to renew four (4) times.

Request for Quotation Instructions

1. All shipments are to be F.O.B. destination. Freight charges must be included in quotation. Delivery shall be made to the address listed on the Purchase Order and within the time specified in the quote.
2. Quotations subject to terms set forth herein, are requested on the following list of materials, supplies or services. On quotes for services, Chatham County insurance requirements must be met. The successful vendor must provide the County with a Certificate of Insurance listing the County as Certificate Holder.
3. Quotes for materials, supplies, vehicles, and/or equipment must be accompanied by Brochures, or copies of detailed factory specifications, ratings, technical data, including accurate descriptions of the exact materials, supplies, vehicles and/or equipment for which bids are made.
5. All information required by request for quotation must be completed to constitute a proper bid.
6. Vendor warrants that the goods are merchantable and as described herein or in the solicitation response. Additional warranties may be called for in the specifications.
7. Chatham County is exempt, by law, from any and all federal and state taxes. Do not include taxes in your quotations. Tax exemption number is **58-6001113**. Exemption certificate will be provided upon request.
8. Price Protection Period of ninety (90) days for all items desired from date of bid opening. Vendors are advised that prices in effect at time of bid shall apply and not be subject to revision at time of shipment.
9. The County reserves the right to split this award by line item if deemed to be in its best interest.
10. Minority/Women Business Enterprise (MWBE) Policy: It is the policy of the County to provide minority and women owned business enterprises with equal opportunity for participating in selling goods and services to the County.
11. **Local Preference:** Bids will be evaluated in accordance with the County's Local Preference ordinance.
12. **Employment Eligibility Verification:** As required under Senate Bill 529 – “Georgia Security and Immigration Compliance Act” of 2006, O.C.G.A. Section 2, Article 3 13-10-91, public employers, their contractors and subcontractors are required to verify the work eligibility of all newly hired employees through an electronic federal work authorization program. The Georgia Department of Labor has added a new Chapter 300-10-1, entitled "Public Employers, Their Contractors and Subcontractors Required to Verify New Employee Work Eligibility Through a Federal Work Authorization Program," to the Rules and Regulations of the State of Georgia. The new rules designate the “Employment Eligibility Verification (EEV) ” operated by the U.S. Citizenship and Immigration Services Bureau of the U.S. Department of Homeland Security as the electronic federal work authorization program to be utilized for these purposes. 13. O.C.G.A. § 50-36-1, requires Georgia’s cities to comply with the federal **Systematic Alien Verification for Entitlements (SAVE) Program**. SAVE is a federal program used to verify that applicants for certain “public benefits” are legally present in the United States. Contracts with the County are considered “public benefits.” Therefore, the bidders are required to provide the Affidavit Verifying Status for Chatham County Benefit Application prior to receiving any County contract. The affidavit is included as part of this bid package.
14. The original invoice is to be submitted to the County Finance Department. The purchase order number must be shown on all invoices and packing lists.
15. References may be requested of the successful bidder.
