PLEASE SEE THE FOLLOWING ADDITIONS, CLARIFICATIONS AND/OR CHANGES:

1. **Change - Section 4.2.1 - shall read as follows: Contractor shall furnish trash containers ranging from 2 cubic yard capacity to 8 cubic yard capacity with removal service from 1 to 6 times per week at various locations throughout Chatham County. Contractor will provide refuse service to provide an 8 yard trash compactor located at the Parking Garage with scheduled collections as stated herein. The power source is three phase. Contractor is also responsible to ensure that compactor is maintained and operational.**

2. **Replace previously issued bid sheet with revised bid sheet.**

3. **Question: What size is the VIP compact at the courthouse? Would the contractor have to get the exact size that is currently being used?**

Answer: Current size is 8 yard. The contractor must use what is specified in bid and addendum.

4. **Question: How much is the current lease price for the compactor?**


Answer: The current contract price is \$475 per month.
