2. All septic tanks serving the mobile homes requiring demolition shall be removed. Drain field does not have to be removed. Tank shall be pumped, removed and then backfilled with sand.
3. Page 26 of the Bid Package shall be revised to give the demo contractor 10 calendar days (not 14 days) for demolition of the first structure following expiration of the 10 day Notice to Proceed. In addition, 10 calendar days (not 14 days) will be allowed for each additional structure included on the parcel.
